

MEMBERSHIP APPLICATION/ PRODUCER RESPONSIBILITY TRANSFER TO ICT PRODUCER CO-OPERATIVE

We apply for membership in ICT Producer Co-operative. We agree to commit to rules and <u>regulations</u> of the co-operative and to take care of the responsibilities. Alike we approve of the co-op's right to revise the authenticity of member companys' reports.

Producer responsibility is transferred and membership begins when the application has been approved according to ICT Producer Co-Operative's <u>regulations</u>.

Companies that also put portable batteries, accumulators or electrical and electronic equipment containing batteries/accumulators on the Finnish market need to make a separate producer responsibility transfer agreement with Recser Ltd: www.recser.fi. INSTRUCTIONS FOR FILLING THE FORM

Auxiliary company names: Company's auxiliary company names related to electrical and electronic field.

Affiliates: If there are affiliates that the company wants to register under the parent company's membership, then an *affiliate form* must be attached to membership application: http://www.elker.fi/en/tuottajayhteisot_en/ict-tuottajaosuuskunta_en/liittyminen_ict_en. In this case, products put on the market by affiliates must be reported on the parent company's form.

Producer responsibility started: From which month and year the company has put electrical and electronic equipment on the Finnish market. After joining the company needs to report B2C products retrospectively for three years prior to the joining year.

Sales of EE-equipment on the Finnish market (€): Company must give the euro amount of the sales of electrical and electronic equipment on the Finnish market (previous financial year). EE-equipment sales determine the joining fee. New companies that have no operations the previous financial year can mark 0 €.

Contact persons: Reporting contact person takes care of company's recycling fee reporting and annual reporting to producer organisation. The company must make sure the reporter's contact details are always up-to-date.

Products the company puts on the market contain: Distribution channel is not significant in defining products as B2C or B2B. All lamps, lighting equipment, small household appliances, thermostats and heaters are products suitable for household use.
