We apply for membership in SELT Association. We agree to comply with the rules and [regulations](#) of the association and to take care of the responsibilities. Alike we approve of the association's right to revise the authenticity of member companies' reports. Producer responsibility is transferred and membership begins when the application has been approved according to SELT Association's [regulations](#).

INSTRUCTIONS FOR FILLING THE FORM

Auxiliary company names: Name of auxiliary company/companies, related to electrical and electronic field.

Affiliates: If there are affiliates that the company wants to register under parent company's membership, then an Affiliate Form. must be attached to membership application. In this case, products put on the market by affiliates must be reported on the parent company's form.

Producer responsibility started: From which month and year the company has put electrical and electronic equipment on the Finnish market. After joining the company needs to report B2C products retrospectively for ongoing year.

Total turnover for previous financial year (€): Company applying for membership needs to declare the company's turnover for the previous financial year. New companies that have no operations in the previous financial year can mark 0 €.

Contact persons: Reporting contact person takes care of company's reporting to the producer organization and acts as a contact person in producer responsibility matters. The company must make sure the reporter's contact details are always up to date. All contact persons given on the form are added to mailing list.

Definition of B2B and B2C: Distribution channel is not significant in defining products as B2C or B2B. All lamps, lighting equipment, small household appliances, thermostats and heaters are products suitable for household use. Read more about Definition for B2B and B2C.
